AN ORDINANCE TO AMEND THE BUDGET ORDINANCE FOR FISCAL YEAR BEGINNING JULY 1, 2010 AND ENDING JUNE 30, 2011.

WHEREAS, Kershaw County Council adopted and enacted; Ordinance No. 158.2010 - Budget;

WHEREAS, Kershaw County Council desires to make a supplemental appropriation and to amend the above referenced Ordinance for certain purposes, including:

An Appropriation of Funds from the Victim's Advocate Fund Balance to Create Two New Victim Advocate Positions in the Kershaw County Sheriff's Department and to Equip Two New Victim Advocate Positions;

NOW, IT IS HEREBY ORDAINED by Kershaw County Council that the Funds as shown on the attached Exhibit are hereby Appropriated as part of the Kershaw County Budget for the Fiscal Year beginning July 1, 2010 and Ending June 30, 2011, and incorporated therein for the purposes stated, and except as amended the Budget Ordinance is reaffirmed.
