

Ordinance No.: 147.2009– Budget

AN ORDINANCE TO AMEND THE KERSHAW COUNTY BUDGET
FOR FISCAL YEAR 2009/2010; TO AMEND FEES AND TO ESTABLISH SOURCES AND MAKE
SUPPLEMENTAL APPROPRIATION FOR THE GENERAL FUND OF SAID COUNTY FOR THE FISCAL
YEAR 2009/2010

NOW, THEREFORE, BE IT ORDAINED BY THE KERSHAW COUNTY COUNCIL:

1. That building and specialty permit fees of the Planning & Zoning Office for Kershaw County Annual Budget for Fiscal Year 2009/2010 be amended to reflect the following:

a. Building Permit Fees

<u>Building Value Range:</u>	<u>Fee:</u>
0 – 5,000	\$50.00
10,001 – 50,000	\$50.00 1 st \$10,000 + \$7.00 each additional \$1,000

b. Specialty Permit Fees

<u>Project Cost:</u>	<u>Fee:</u>
0 – 10,000	\$35.00 (one inspection) + \$35.00 each additional inspection

2. The holiday schedule listed in Section 8, paragraph J for regular full-time employees, excluding law enforcement, fire service, detention center, and central communications categorized as public safety to amended to reflect the following:

Independence Day
Labor Day
Thanksgiving Day and the Day After
Christmas Eve
Christmas Day
New Year's Day
Martin Luther King's Birthday
Good Friday
Memorial Day

3. That the receipts, appropriations, and expenditures for the Kershaw County Budget for the Fiscal Year 2009/2010 are amended to reflect the levels indicated below:


4. Except as amended herein, the Budget Ordinance originally enacted remains the same.


5. That this Ordinance shall become effective upon the third and final reading.


