The user desires to discharge domestic sewage into the County's wastewater collection and treatment system, and agrees:

1. The County shall furnish collection and treatment services subject to the limitation hereinafter provided.
2. The user shall install and maintain, at the user's own expense, a service line which shall begin at the user's property line and extend to the dwelling.
3. The user's service line shall connect to the collection system of the County at a location agreed to between the County and the user, provided the County has determined in advance that the sewer system is of sufficient capacity to permit collection of sewage at that point.
4. The user shall pay for such sewer service at such rates, times, and place as are outlined in the Rate Schedule. The Rate Schedule as established by the County is subject to change.
5. Monthly sewer use charge shall be **based upon actual water consumption** as recorded by water meters or as provided in the Rate Schedule.
6. The user shall not connect any additional dwellings or residence to be served.
7. The County shall have final jurisdiction in any questions of location of any service line connection to its collection system and may shut off sewer service to a user who allows a connection or extension to be made to his service line for the purpose of accepting sewage discharge from another user.
8. The user shall abide by rules and regulations as established by the County, S.C. DHEC or any other regulatory agency.
9. The failure of a user to pay sewer service charges shall result in the automatic imposition of penalties, disconnections and reconnect fees as established by the County. These penalties and reconnect fees are subject to change.
10. **If the sewer user is a tenant of the service property then both the tenant and property owners must sign application.** As established in the County's Sewer Use Ordinance, Section 13-8 Responsibility of when units are vacant, states "It shall be the responsibility of the owner of any units to make payment of all sewer rates, fees and penalties when the units are vacant."
