



Bark Park Rules

Kershaw County Parks & Recreation has a 2.58 acre fenced, off the leash area for dogs to run and play. The Bark Park features an agility area with several pieces of agility equipment for dogs to exercise and show off their athletic abilities. The park also features an interactive fire hydrant sprayer, 2 watering stations, benches for owners to relax, 2 dog wash stations, and a large dog and small dog open space.

Bark Park Pass

Bark Pass memberships can be purchased at the Kershaw County Parks & Recreation Department office. Office address is 1042 West Dekalb Street Camden, SC 29020. The Bark Parks hours of operation will be open 7 days a week. Spring & Summer Season will be Sunday - Saturday 8:00 AM - 8:00 PM, and Fall & Winter Seasons will be Sunday - Saturday 8:00 AM - 6:00 PM. Fee: \$40 per year for Kershaw County residents and \$50 per year for out of County users. Each pass is good for up to two dogs in the household. Additional dogs require a second pass. No wolves or wolf hybrids are allowed.

Bark Park applicants must provide the following documentation:

- Rabies vaccine
- DHLPPV
- Canine bordetella vaccine
- Parvo vaccine
- Spay/neuter

***** No History of bites or aggressive behavior*****

Bark Park Rules

1. Use of the Bark Park is for the Kershaw County Bark Park pass holders and their registered dog (s). Users **MUST** have a signed liability waiver on file at the Kershaw County Parks & Recreation office.

3. People entering the park do so at their own risk.
4. Owners are responsible for their dogs at all times and could be liable for injury to others.
5. Children who are at least five (5) years old and less than sixteen (16) years old are permitted in the Bark Park as long as they are accompanied by a parent/guardian.
6. No food or treats are allowed in the Bark Park. Owners are allowed to bring balls,

frisbees, and other dog toys to share. Any toy resulting in threatening or aggressive behavior must be removed immediately from the park.

7. Smoking is not permitted in the Bark Park.
8. Dogs must be leashed prior to and upon leaving the dog park area. Owner shall have a leash in their possession at all times while in the dog park area and ensure dog(s) have on a collar at all times while in the Bark Park. All pinch, shock, prong, and spiked collars must be removed prior to entering the dog park area.
9. Access to the dog park may be restricted during special events. If so, notice will be posted.
10. Dog owners must do the following while inside the Bark Park:
 - Must remove their dog if their dog shows aggressive behavior.
 - Shall remain inside the enclosed areas and must keep their dog(s) within sight and voice range at all time; dogs may not be left unattended.
 - Must clean up after their dogs using designated bags and containers.
 - May only supervise 2 dogs at a time.
 - Are responsible for filling in any holes caused by digging.
